JOB DESCRIPTION

MAJOR RESPONSIBILITIES OF COACH & BENCH STAFF

All head coaches must be professing Christians and be recognized as putting their faith into action in their family, workplace, church and community. In addition the coach:

1 – Must follow the aims and goals of Carolina Forest Community Center (hereby known as CFCC) as outlined through its mission and policies, therefore, prepared to lead the team by modeling a Christ-like attitude in word and action.

2 – Must ensure the objectives as outlined in the Coaches Manual are met.

3 – Shall strive to ensure Fair Play Codes (see below) as set out by CFCC.

4 – Shall ensure practices are effective and well planned.

5 – Shall refrain from the use of foul language during all team functions.

6 – Shall pledge themselves from abstaining from alcoholic drink, illegal drug use, and inappropriate sexually or radically motivated behavior during the course of service.

7 – A coach may compile a set of “Team Rules” which must be submitted to CFCC for approval, prior to enforcing these rules on the team.

8 – Eligible applicants will be required to pass a Police Record Check.

Fair Play Code of Conduct For Coaches

- I will be reasonable when scheduling practices, remembering that players have other interest and obligations.
